- I. Call to Order:** At 10:10am, Jamie Horne brought the meeting to order on September 1, 2016.
- II. Invocation and Pledge of Allegiance:** Dr. Horne gave the invocation, and the committee recited the Pledge of Allegiance to the American Flag.
- III. Items from Audience:** There were no items brought before the committee from the general public to be addressed.
- IV. Present Proposed Agenda:** The agenda was presented to the team by Dr. Horne along with a copy of the School Improvement Plan.
- V. Consent Agenda:** Becky Lewis made a motion to accept the Consent Agenda; the motion was seconded by Will Southwell. The motion passed unanimously.
- VI. Items for Action by the Local School Governance Team:**
- A. Election of Officers: Dr. Horne informed the committee the LSGT ran on a two year term schedule. The team needed to elect a Chairman, Vice Chairman and Treasure for the 2016-2017 term. The following positions were approved by a unanimous show of hands. Chairman : Will Southwell, Vice Chairman: Becky Lewis, Secretary: Amanda Holt.
- B. Local School Governance Bylaws: Dr. Horne reported that as a Charter System, we are to be on or above grade level (for reading) by 2019-2020.
- C. Meeting Dates and Times: Dr. Horne reviewed the schedule for the remaining LSGT meetings. They will be at 10:00 in the WJW cafeteria on the following dates:

- D. Review of LSGT Modules 1 and 2: Dr. Horne discussed Modules 1 & 2.
- E. Review of LSGT Modules 3 and 4: Dr. Horne discussed Modules 3 & 4.
- VII. Information Items from the Principal/Curriculum Director:**
- a.) Personnel – Resignations and Retirements:  
Dr. Horne reported four teachers retired and several transferred to other schools. There have been a total of 17 teachers hired.
- b.) Finance/Resource Allocation:  
The Bleachers, which are first on the list for WJW SPLOST Projects has been moved to be completed after a need is met at the High School. Mr. Southwell reported the cameras that have been installed are working well and accomplishing many misbehavior and disciplinary issues. Dr. Horne informed the team WJW will be purchasing a new lawnmower to keep the facility well groomed.
- c.) Curriculum News: Thirty nine percent of the incoming 6<sup>th</sup> graders are below grade level in reading. Thirty seven percent are at the “basic” level and 25% are proficient or above. The seventh graders have 29% below reading level, 41% at basic level and 30% below.
- d.) School Improvement Plan: Dr. Horne explained the School Improvement Plan tells us where we need to be and what we need to work on. It is a working document that can be manipulated as needed throughout the year.
- e.) School Operations: Dr. Horne reported the cafeteria, for the past 2 years, has fed 200 breakfast and 1000 lunches a day. They are currently feeding 500 breakfast and 1125 lunches. A part time custodian has been added to the north campus and an additional Ag teacher due to the importance agriculture has to our community.
